Club functions such as these can only take place if individual members offer some of their time. Helping with these events can significantly enhance the enjoyment of your membership.

Club Master Plan Update

The Building Committee has been working since last spring to bring the FMWSTC Master Plan to realization. The Club thanks volunteer Committee members Bill Jordan (Chairperson), Greg Dolson, Bob Root, Donna Sohinki, and John Waldren for their outstanding efforts to date.

The Committee's initial action was to find an engineering firm to develop the site plan. The committee conducted a search in which six commercial teams submitted proposals for FMWSTC's next phase. Proposals were evaluated for responsiveness, overall team strength, engineering capability, and cost. The winning team is composed of an engineering firm, Burgess & Niple; a pool company, Maryland Pools; and an architectural firm, David Clark & Company. The Burgess & Niple team was a clear winner technically and financially over the other proposals.

After signing a contract last July, the Burgess & Niple team began developing the engineering site plan. This site plan is the next sequential step in the process that will yield a detailed set of engineering drawings. The site plan drawings will allow construction firms to provide a bid for constructing the pool.

In the initial process, Burgess & Niple engineering has emphasized storm water retention. David Clark has been reviewing the overall layout and the design of the building structures. Maryland Pools is developing the swimming pool design and will provide several alternatives for the new shallow end. The site plan requires Fairfax County approval and, as with all county approval processes, progress has been slow. As information becomes available, it will be displayed at the pool.

Mark Hubal is serving as the Board of Directors liaison, and will be working closely with Bill Jordan and the Building Committee. If you have any questions, please contact Mark, Bill or other committee members.
